

## *Non-Discriminatory Policy*

A school tuition organization cannot award, restrict, or reserve scholarships only on the basis of a donor's recommendation. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent. ARS 43-1603 Also, a parent may not make a donation recommending his/her own child or dependent.

## Dear Family and Friends,

Mountain Christian School would like to invite you to participate in Arizona's Tuition Tax Credit Program. By making a donation, you can receive a **dollar for dollar** credit on your Arizona state income taxes, up to your actual tax liability, or the limits listed in this brochure, whichever is less.

Students are not only receiving a scholarship, they are receiving a solid, educational and spiritual foundation on which to build the rest of their lives. **Because of your donation**, many students who otherwise couldn't, will be able to build a life-changing foundation at Mountain Christian School.



These donations can be in small monthly installments, or in one lump sum. Any donation made will directly lower your tax liability and **help you decide exactly where your state tax dollars will be spent**. In addition, you can donate to both your public school and MCS. Tax credit donations may also qualify as charitable contributions on your federal return as well!



## Overflow/PLUS - **NEW!**

In 2012, Arizona signed the new Overflow/PLUS tax credit into law, allowing donors to receive an additional credit over and above the original tax credit. Overflow/PLUS funds can only be awarded to students who meet any of the following eligibility requirements:

- 1** *The student attended an Arizona public or charter school for at least 90 days in the prior school year.*
- 2** *The student is currently enrolled in Kindergarten.*
- 3** *The student is a dependent of a member of the US Armed Forces who is stationed in Arizona.*
- 4** *The student previously received a corporate or Overflow/PLUS scholarship and has continuously attended private school since then.*

The Arizona taxpayer must first donate the maximum allowed for the original tax credit in order to donate an additional amount to the Overflow/PLUS tax credit. **Donations can be made using just one check.**

## Recommendations

Donors may recommend a student for each scholarship, but scholarships are subject to the absolute discretion of the STO. The form which accompanies this brochure may be used to designate a student. If left blank, the donation will go to the general scholarship fund of the school.

## April 15 Relateback

April 15 Relateback: A person may donate prior to filing taxes, but no later than April 15, and claim the credit for the previous year's taxes. There are no extensions.

Donations must be postmarked no later than **April 15**.

## 2017 Tax Credit Maximums

### Original Tax Credit

Single Taxpayer	Married Filing Jointly
\$545	\$1092

Or your actual tax liability (whichever is less). Claim credit on AZ Form 323

### Overflow/Switcher

Single Taxpayer	Married Filing Jointly
\$541	\$1085

Or your actual tax liability (whichever is less). Claim credit on AZ Form 348
